

ER13-1605-000 and ER13-1607-000 on July 1, 2013, and in Docket No. EC13-113-000 on July 30, 2013, on behalf of the Commission in the Federal Energy Regulatory Commission proceedings considering requests of Nevada Power Company and Sierra Pacific Power Company to integrate their operating companies and revise the transmission and ancillary services rates and other terms and conditions in their Open Access Transmission Tariff.

Please be aware that after the quasi-judicial Commission has rendered a decision in a contested case and assuming this happens before adjournment, then the Commission's Senior Deputy Attorney General may advise the Commission that it may entertain public comment on the proceeding at that time.
