A public meeting of the Colorado River Commission of Nevada will be held at **1:30 p.m.** on **TUESDAY, JANUARY 10, 2017**, at the **CLARK COUNTY GOVERNMENT CENTER, COMMISSION CHAMBERS, 500 SOUTH GRAND CENTRAL PARKWAY, LAS VEGAS, NEVADA.**
